
ORDER

AND NOW, this 21st day of January, 2011, following discussion and upon agreement of counsel for the parties, it is hereby ORDERED as follows

1. The hearing scheduled for January 21, 2011 is continued.
2. Counsel for Plaintiffs shall advise counsel for Defendants no later than February 25, 2011 whether any further continuance is acceptable to them.
3. If a further continuance is not acceptable, counsel for Defendants shall file any renewed Motion to Stay/Motion to Dismiss and supporting brief no later than February 28, 2011.
4. Counsel for Plaintiffs shall file their opposition response and brief to any renewed motion no later than March 3, 2011.

5. If either counsel desire oral argument by telephone, they should advise the Court no later than March 4, 2011.
6. The Court shall endeavor to rule on the renewed motion no later than March 8, 2011.
7. If the Court desires oral argument it will advise counsel as soon as possible.
8. The hearing, unless further continued, shall commence on March 15, 2011 at 9:00 AM in a courtroom to be identified in the Dauphin County Courthouse.
9. If a continuance is acceptable to Plaintiffs, counsel shall coordinate a conference call with the Court to discuss and set future scheduling.
