AND NOW, this 16<sup>th</sup> day of August, 2011, it is hereby **ORDERED** that:

1. The court shall conduct a hearing on Plaintiff's Motion for an Order of Mandamus Pursuant to Section 8261 and 8263 of the Local Government Unit Debt Act and For Equitable Relief on *September 22, 2011, at 11 o'clock a.m. and September 23, 2011 at 9:00 a.m., if necessary*, in Courtroom No. 1, Fifth Floor, Dauphin County.
2. Counsel shall submit and file any stipulated amendments to the pleadings, as sought by the Defendant City of Harrisburg, on or before *September 14, 2011*. Requested amendments to which counsel do not stipulate shall be presented by way of a Motion for Leave to Amend, which Motion shall be filed in such time as to allow response by other parties and consideration by the court without causing delay of the scheduled hearings.
3. Counsel shall submit and file any Stipulation of Facts relevant to the hearing on Mandamus not later than *September 14, 2011*.
4. The court shall conduct a hearing on Plaintiff's Motion for the Appointment of a Receiver Pursuant to the Local Government Unit Debt Act on *October 17, 2011 at 9:00 a.m.* in Courtroom No. 1, Fifth Floor, Dauphin County, and

on *October 19, 2011 at 9:00 a.m.*, if necessary, in a courtroom to be announced.
