**ORDER SETTING OBJECTION AND BRIEFING DEADLINES
AND SCHEDULING HEARING**

After a status conference held on October 17, 2011 regarding the Chapter 9 Petition (the "Petition") filed by certain City Council Members of the City of Harrisburg (the "Petitioners"), the Objection and Motion of the City of Harrisburg, through its Mayor, the Honorable Linda D. Thompson, Seeking to Vacate or Modify the Order entered at Docket No. 14 (the "Mayor's Motion"), and the Objection of the Commonwealth of Pennsylvania to the Chapter 9 Petition of the City of Harrisburg (the "Commonwealth Objection"), it is hereby ORDERED AND DECREED that:

1) The deadlines contained in the Order entered on October 14, 2011 at Docket 14 ("October 14 Order") regarding the advertising of the notice of commencement of case are hereby vacated and are subject to further order of this Court. The deadlines regarding the filing of objections to the Petition and setting a preliminary hearing contained in the October 14 Order are hereby modified by the within Order.

2) The following dates are hereby set regarding Objections to the Petition:

(A) Any and all Objections to the Petition with respect to the Debtor's authority to file under Section 109(c)(2), including *inter alia*, the Debtor's authority under Pennsylvania Act 26 and Act 47, the Third Class City Code, Act of June 23, 1931, P.L. 932, as

amended, 53 P.S. § 35101 et seq., and/or the Optional Third Class City Charter Law, Act of July 15, 1957, P.L. 901, as amended, 53 P.S. § 41101 et seq., shall be filed and served on or before October 28, 2011.

(B) Any party objecting to the Petition shall file and serve a brief in support of their Objection to the Petition on or before October 28, 2011;

(C) Response(s) to the Objections shall be filed and served on or before November 7, 2011;

(D) Brief(s) in Support of any Response(s) shall be filed and served on or before November 7, 2011;

(E) Any Objecting party may file and serve a Reply to any respective Response(s) on or before November 12, 2011, provided such Reply shall not exceed a 25-page limit without authorization of the Court;

(F) No Sur Replies shall be filed;

(G) Argument with respect to issues of law raised by the Objecting Parties and Petitioner is scheduled for November 23, 2011 at 9:30 AM in Bankruptcy Courtroom One, Third Floor, Ronald Reagan Federal Building, 228 Walnut Street, Harrisburg, Pennsylvania;

(H) Any further objection(s) to the Petition under any other subsection of 11 U.S.C. Section 109(c) are preserved by the Objecting Parties.
